Three state insurance regulators license/register these programs and publish authoritative lists, which anchored much of this directory: the [North Carolina Department of Insurance list of licensed Continuing Care at Home providers](#), the [Virginia SCC list of Community-Based Continuing Care \(CBCC\) disclosure statements](#), the [Connecticut DSS continuing care facility disclosure statement index](#), and the [Maryland Department of Aging Continuing Care provider directory](#) (which has a dedicated "CCAHS" section).

Programs found but with unconfirmed or partial details

- **WesleyLife At Home / WesleyLife CCaH program (Iowa).** LeadingAge reports that WesleyLife of Des Moines, IA has operated a Continuing Care at Home program for about two years ([LeadingAge](#)), and WesleyLife publishes CCaH explainer content ([WesleyLife](#)), but no branded program name, office city, or program phone appeared on the pages fetched. Phone: n.a.
- **Edenwald (Towson, MD).** Named by LeadingAge as a member with a CCaH program ([LeadingAge](#)); Edenwald's own site (410-339-6000, Towson, MD — [Edenwald](#)) does not describe a separate at-home membership plan. It announced an affiliation with Wesley SecureCare in 2024, which is the listed Maryland CCaH provider, so the two may now be one offering.
- **Vibrant Living at Home (Florida).** Program is real and clearly a CCaH membership plan ([Vibrant Living at Home services](#)), phone 407.515.8199, but no city/state is published on its site.

- **Connected for Life (North Hill, Needham, MA).** Program described in trade press ([Advance Senior Care](#)); the phone in the table is North Hill's main number, not a dedicated program line.
- **Whitney Center, Inc. (Hamden, CT)** operates both Thrive at Home programs (its own and the McLean-branded one), per the [Connecticut DSS disclosure index](#). Treat the two Thrive at Home rows as sister programs under one operator.
- **Alexian Brothers "Live At Home" (Chattanooga, TN).** Documented in a 2006 trade article ([Levin Associates](#)); no current program page was found. Status: likely discontinued.
- **Seed-list names that could NOT be verified as CCaH programs** (no fetched page shows an at-home continuing care membership plan): Broadmead "At Home" (Cockeysville, MD — [Broadmead](#) shows no at-home membership program; the "Long Term Care @ Home" hits belong to unrelated Broadmead Care in British Columbia), Lourdes Health at Home, Beacon Hill Village (a member-run aging-in-place "village," not a life-care contract — [Beacon Hill Village](#)), Erickson Senior Living at-home programs (Riderwood, Cedar Crest, Ann's Choice), Fellowship Square at Home, National Church Residences "Community at Home," Front Porch "Splendid Living at Home," Vi at Home, Ohio Living at Home, Otterbein at Home, Twin Lakes at Home, Wesley Homes at Home (Washington), Cross Keys Village at Home, Masonic Village at Home, Homestead Village at Home, Simpson House at Home, Pennswood Village at Home, Bishop Spencer Place at Home, Bethany Village at Home (PA), Westminster at Home (Lynchburg, VA — a home health agency), Deupree at Home (Episcopal Retirement Services markets community-based services, not a named CCaH plan), Landis at Home (Landis Communities partners with Friends Life Care instead), Connections at Home VIA Willow Valley (a home-care brand, distinct from SmartLife), Givens Communities "at Home" (the actual program is Givens Choice, listed above).

How to find more programs

1. **State insurance/aging regulators are the highest-yield source**, because CCaH plans are regulated like continuing-care contracts in several states: [NC DOI's licensed CCaH provider list](#), [Virginia SCC's CBCC disclosure statements](#), [Connecticut DSS's continuing care disclosure index](#), [Maryland Department of Aging's Continuing Care Directory](#), and the Pennsylvania Insurance Department's posted CCRC disclosure statements (searchable by filename, e.g. the [Friends Life Care](#) and [SmartLife](#) filings). Ask each state's DOI for the current registry; several publish only PDFs.
2. **LeadingAge's Continuing Care at Home Network** is the trade body for this niche; its annual [CCaH Virtual Conference program](#) names sponsoring programs (which is how Ginger Cove, Edenwald, McLean, Whitney Center, Landis and others surfaced here), and its [CCaH white paper](#) and [benchmark-survey coverage](#) name others. Contacting LeadingAge (or state affiliates such as LeadingAge PA, LeadingAge NJ & DE, LeadingAge Virginia) for the current Network roster is the single most efficient next step.

1. ****Search the alternate brand vocabulary****, since almost no program is called "con

1. **Work backwards from life plan communities.** Nearly every CCaH plan is a subsidiary of a nonprofit CCRC. Scan state CCRC/Life Plan Community rosters (e.g. LeadingAge state affiliate directories) and check each operator's site for an "at home," "choice," or "membership" tab.
2. **Trade press is a good tripwire for new launches:** Home Health Care News, Senior Housing News and McKnight's Senior Living cover launches regularly — e.g. Judson's 2025 membership launch, Duncaster's LifeCare On the Go, and Pathstones/Lakewood at Home coverage.
